

From the far end of the Nation I am compelled to write this letter to express my profound sadness, grave concern and alarm at the chaotic spectacle of brownshirt torches in the night, such gratuitous aggressiveness and such moral delusion as has afflicted Charlottesville this weekend. One can only hope we All share Mayor Signer's nausea at the "cowardly parade of hatred, bigotry, racism, and intolerance marching down the lawns of the architect of our Bill of Rights."



It permits someone to be credited for their psychoanalytic (or Jungian) training towards a Psya.D. While it is not a degree leading to licensure, some of our members and candidates may have other personal or professional reasons for obtaining a Psya.D while utilizing their IRSJA training.

Boston Graduate School of Psychoanalysis Doctor of Psychoanalysis (Psya.D.) Degree Low-Residency, Accelerated Track

The low-residency, accelerated track towards the Doctor of Psychoanalysis (Psya.D.) degree provides the opportunity for already certified psychoanalysts to earn a doctoral degree in psychoanalysis through distance learning, combining video conferencing and weekend intensives in Boston. Emphasizing advanced comparative clinical seminars and research methodology, the program is designed to bring together a theoretically diverse group of psychoanalysts to generate more discussion and research in the field. Doctoral candidates study comparative approaches to clinical intervention and contemporary issues in psychoanalysis while contributing original doctoral research to the field.

Format

Students attend two weekend intensive sessions per semester in Boston, for two years. The remaining classes are held via video conferencing over the internet.

Admission

To be eligible for admission, candidates will have earned a post-master's certificate in psychoanalysis. It is expected that applicants will have already earned the equivalent of at least 36 credits of post-master's psychoanalytic coursework, including psychopathology, psychoanalytic theory, developmental theory, dreams and symbolic processes, intervention, transference, countertransference, and resistance, as well as case seminars. Suitable applicants will also have significant psychoanalytic experience, will have received extensive psychoanalytic clinical supervision, and will have undergone a training analysis. Applicants submit a qualifying paper that provides evidence of the critical thinking, writing skills, and psychoanalytic understanding required to conduct doctoral research in psychoanalysis.

Degree requirements

The accelerated Psya.D. program can be completed over a two year period, with 2-3 courses per semester, in addition to the completion of the dissertation. The program requires 37 credits, including 10 credits of research methods course work, 6 credits of case seminar, 11 credits of additional coursework in psychoanalysis, and 10 credits of directed research supervision as the student works on the dissertation.

- Completion of 37 credits of required and elective course work.
- Successful completion of the dissertation and oral defense to the faculty

Trauma, Dissociation, and the Soul A Certificate Training Program

A Limited-Enrollment Intensive for Clinicians With Donald Kalsched, Ph.D. At Pacifica Graduate Institute, Santa Barbara California Three Four-Day Sessions in 2017-2018 (November 1-5, January 8-11, February 28--March 4)



This program is an opportunity for clinicians from a variety of disciplines to explore the clinical, theoretical, and symbolic/spiritual dimensions of Donald Kalsched's model of the inner world of trauma and its archetypal defenses of the imperishable personal spirit or soul - as described in his two books, many articles, and four decades of Jungian analytic practice. This understanding of dissociative structure, described as the *Self-Care-System (SCS)*, holds open the possibility of a new way of thinking about the symbolic processes in trauma as they open a window into the mystical dimensions of existence, a new way of understanding other contemporary dissociative models of the mind, and a new way of envisioning the unique contribution of Jungian Depth Psychology to modern clinical practice.

In each of the three extended sessions of the program, different facets of the model and its implications for understanding and healing trauma, while restoring the soul to embodied life, will be discussed. Film-clips will be used throughout as illustrations, and assigned reading between sessions will add important developmental background, especially in the areas of infant observation, attachment theory, and affective neuroscience. The program will take place on the Ladera Campus of Pacifica Graduate Institute in Santa Barbara, California. Housing for all participants is offered in the Retreat Facilities of Pacifica Graduate Institute.

- First Session—Mapping the System Through Dreams, Transference, and Film
- Second Session—Transactional Pathology and Treatment Approaches
- Third Session: Mystical Dimensions of Psychotherapy with Trauma Survivors
