



News from the desk of Don Kalsched in Topsham, Maine

Don Kalsched taught in the Zurich Summer Program last July and will be returning this July for three days teaching and supervising the candidates in the Küsnacht program.

He has also been donating 2 hours/week to a group of Ukrainian Jungian colleagues who are trying to become better informed about the Supervision process in order to start a training program there after the war. In addition, he did a Webinar for the group "With Ukrainian Jungians" on September 19th of last year in which he gave a longer version of the article below. As a part of this webinar, three Ukrainian women gave brief responses and all three will have their talks published in *Psychological Perspectives* this Spring with a commentary by Don.







Greg Mogenson has just published a new book:

Notional Practice: The Speculative Turn in Analytical Psychology

Greg Mogenson

This book brings together in one place a selection of its author's many contributions to psychology as the discipline of interiority. Beginning with an "Introductory Chronicle," the author provides a lively account of his long collaboration with Wolfgang Giegerich as editor of the latter's Collected English Papers. Included in this chronicle are accounts of the negations his own understanding of Jungian psychology had to go through during this period, as well as insights into the problem of the transference as this plays out within schools of thought that are rooted in the concepts and insights of master representatives dating back to Freud and Jung. Stories are told of the author's occasionally hair-raising adventures as a lecturer and teacher. Crash courses are offered that highlight what is special about PDI. And dreams are shared that provide a view from within of what "the soul" as psychology goes through in the course of its theoretical pursuits. In the essays that follow the emphasis is upon analytical psychology as a notional practice. Jungian psychology, as Jung courageously insisted, is a psychology with soul. Mirrored in this notion, all manner of human situations may be grasped in their inwardness and depth. Further to this, the essays have also in common the project of elucidating the speculative character of psychology's insights. Although Jung took pleasure in having been described as "an empiricist first and last," his being informed by a concept of the soul that overreaches the subject/object distinction outclassed this description.





SEEKING ANALYSTS TO PROVIDE REDUCED FEE CASE CONSULTATION FOR IRSJA CANDIDATES

In spring 2021, Kaitryn Wertz compiled a list of analysts who are willing to provide consultation (formerly called supervision) to IRSJA training candidates at a reduced fee. In agreement with Kaitryn, the candidates are now maintaining the list and it is being updated annually. If you are not already on the list and are willing to provide consultation at a reduced fee to at least one candidate, please e-mail Carrie Remmell at carrieremmell@gmail.com. I will e-mail you a brief form to complete. The information you provide will be added to the list available to candidates. The fee will be agreed upon between the analyst and candidate.

The candidates are deeply grateful to those analysts who are able to offer a reduced fee for consultation. This helps contain the costs of training for all candidates, especially pre-control candidates admitted since spring 2021 because their consultation hour requirements have increased from 12 to 40 hours per year. Thank you.

Please note: Per the IRSJA training manual, analysts must have five years post-graduation experience to provide consultation to pre-control candidates. Analysts providing consultation to control candidates must also have five years post-graduation experience.

Princeton University Press

We are thrilled to share news of a major new initiative: the publication of The Critical Edition of the Works of C. G. Jung. As the longtime publisher of the Collected Works of C. G. Jung in North America, PUP is honored to be global publisher of the Critical Edition, having recently secured world language rights and the support from the Foundation for the Works of C. G. Jung in Zürich, who will be facilitating and guiding access to documents and letters and providing its expertise to this major undertaking based on family archives.

Led by general editor Sonu Shamdasani — a preeminent expert on Jung who edited and co-translated The Red Book: Liber Novus, among many other projects — this ambitious, multi-year undertaking will result in 26 volumes of material, all newly translated by Caitlin Stephens, that will bring the Swiss psychologist's formidable work to new life for a new generation of readers. Volumes will feature a scholarly apparatus, including historical introductions, contextual annotations that will draw heavily on Jung's unpublished correspondences, and variorum presentations of works that went through multiple editions, noting revisions. Alongside the general editor, Jung historians Gaia Domenici, Martin Liebscher, and Christopher Wagner will serve as volume editors.

DIRECTOR OF TRAINING CORNER, SPRING 2024

From Martha Blake, Director of Training:

The Training Committee continues to build the infrastructure to automate the Training Transcript process.

IRSJA CANDIDATE TRAINING DOCUMENTS: All current and recent Candidate training files are stored electronically now, by Candidate name, on a Google drive that is backed up for security. Marilyn Porterfield of Best Management, the IRSJA management services contractor, actively supports IRSJA documentation activities, including the Training Transcript process. The Training Committee thanks Marilyn Porterfield for her collaboration and service to IRSJA.



TRAINING COMMITTEE DOCUMENT AND FILE CONVENTIONS: The Training Committee needs your help. When Candidates or Analysts send documents to Training Committee members to file in a Candidate file, we sometimes need more information and most often need consistent label formatting. Analysts, please include the Candidates' full name, the date, and the reason for the document near the top of each document. The IRSJA Training Committee adopted the York University document and file labeling and file conventions, to stabilize the document process and to reduce the costs of paying someone else to redo our work—what is called "the cost of rework."

Candidates and Analysts, please:

Identify the Candidate and Analyst by their full legal name. State the name of the document: e.g., Analytic Hours. Sign (or electronically sign) the document.

Most important: When you save a document before you transmit it, label it according to the York Convention: Year, month, day, Candidate name, document/issue. (Example 2024.03.06. *Use the zeros for numbers under 10, or the document will not file correctly.*) THEN AND ONLY THEN, transmit the document. When we all learn to use the York Convention and send each other files already labeled correctly, we are not paying someone else to do our work.

The Training Committee's Local Seminar Coordinator, Jeanne Lacourt, is working with the Local Training Seminar Coordinators to identify an "LTS guru" to support the LTS analysts as we all adjust to and learn how to interact with the new automated Transcript system.

CLIENT AND CANDIDATE FILE SHREDDING: Each state and each licensing board mandates specific time frames for thinning and shredding files. Each Analyst/Candidate must identify their state and licensing body requirements and shred accordingly. Personal story: In the past, I have thinned and shredded my files after ten years. This year, I headed for the APA standard of seven years. Texas law for academic records is five years. The issue is whether a file contains HIPPA information. This month, I thinned my files into nine packed grocery bags, packed full of former client files. I made an appointment with my local Disposal Company. The bags filled a large garbage disposal container to the top. I watched as the shredder person loaded them into the shredder truck. I heard the documents shredding. Then, the shredder person gave me an official HIPAA-compliant certificate of shredding and a bill for \$35.00, which I paid by credit card. I have a receipt to deduct the cost of shredding from my income.

Panel Discussion on Developing Candidate Capacities

The IRSJA Training Committee will sponsor a panel discussion during the Friday morning business meeting in Santa Fe about developing the analytic capacities of candidates. Pat Berry will give a history related to capacity guidelines documented in the 1985 minutes. Carolyn Bates will share a PowerPoint presentation addressing the capacities identified in this historical document that contribute to the analytic attitude and mind. Martha Blake will discuss how the Training Committee realized the need to re-visit the language of our origins about analytic capacities. Mary Coady-Leeper will moderate the discussion.

Following the panel presentations, there will be thirty minutes for questions and comments. We hope analysts will be present who frequently communicate with candidates about their development whether during admissions, consultation, colloquia, propes, review and diploma exam committees, and seminars. Vote on Bylaw Amendment

Also, a reminder that we will be voting at the business meeting on the bylaw amendment proposed at our fall meeting to exempt members over the age of 85 from having to pay dues. The wording is as follows:

AMENDMENT XVIII

MEMBERS

ARTICLE III

SECTION 1. Regular Members

C. Members Emeriti

Upon reaching 85 years of age Emeritus members will no longer be required to pay dues. Their rights and obligations remain the same as an Active Member except they may pay no dues and do not have to meet the attendance requirements.

Five-Year Projected Financial Position

A Heads-Up Contribution from IRSJA Secretary, Kathrin Hartman:

Dear IRSJA community,

Since serving as secretary, I have come across a few miscellaneous things that I thought might be good for us to update. For instance, the member meeting requirement that each IRSJA member should attend "at least one meeting every two years."

Well, the Covid-19 pandemic taught me that the consequences of not attending at least once every two years, in the way it is currently worded in our IRSJA membership manual may be a bit harsh.

With the blessing of the EC, I would like to propose a different language that allows for exceptions while it keeps the spirit of this requirement alive: We need YOU and most of us attending the meetings to make the IRSJA training happen.

Below is the proposal which I plan to formally make at our Spring 2024 meeting: Proposed Language Change for Bylaws Amendment Membership Attendance in IRSJA Membership Manual, Updated February 2024

Current Version, p.7

SECTION 5. Attendance

Members must attend at least one meeting every two years. The Secretary shall be responsible for notifying the Executive Committee of any member who has not met this requirement or who has not requested, in writing, an excused absence. The Secretary shall notify the member in writing that the above action has been taken.

SECTION 6. Resignation or Termination of Membership

- B. Termination Initiated by the Society
- 2. Non-Attendance

Failure to meet the attendance requirement may result in termination of membership by a twothirds vote of the Executive Committee upon notification of the Executive Committee by the Secretary. The member must have four weeks' written notification by Certified Mail of the proposed termination.

Proposed Version

SECTION 5. Attendance

Members will make every effort to attend at least one meeting every two years. The Secretary will contact and communicate with members who have not attended within a two-year period. The Secretary will notify the Executive Committee of the communications. The Executive Committee will consider how to best support each member's active participation in the IRSJA community.
